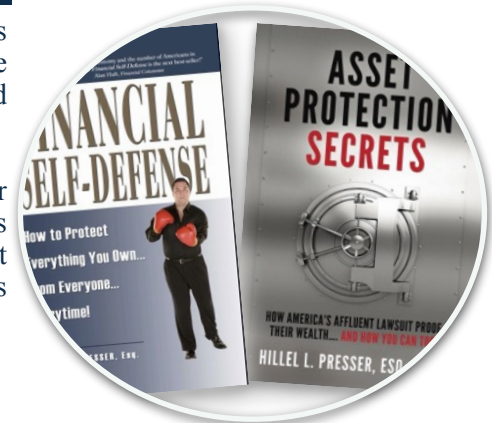
WHO WE SERVE

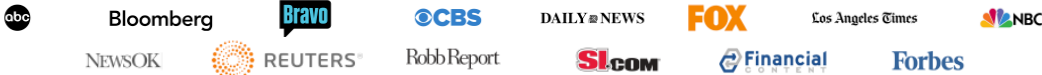
